

The award was accepted on behalf of Living Stones by Pastor Gary and Elder Josephine Montgomery, founders. It was most appropriate for the Executive Director, Josephine, to make the following remarks that "*Living Stones is accepting this award on behalf of the children and families we serve. It is our passion working with these children and families that this award means so much to us.*"

The 4th Annual National Faith Symposium, "*Our Children, Our Future: Restoring Hope*" was held in Orlando, Florida co-sponsored by the Florida Department of Juvenile Justice (DJJ) and the Florida Department of Children and Families (DCF). It was the first time the Champions of Hope Award was presented by the Florida Faith and Community-Based Advisory Council.

Farm Share *

* Farm Share is a distribution network that supplies fresh fruits, vegetables, and surplus food to area food pantries, homeless shelters, and organizations.

Just two weeks ago, Living Stones set up at 7:00 am Saturday November 2, 2013 to distribute food to the Bond Community at Walker Ford Community Center. Individuals were lined up as early as 5:30 am. A full tractor trailer was unloaded about 8:30 am. It took about four hours to unpack crates, bag, and hand out food. The result is that we distributed food to feed 1,012 individuals. Living Stones with Farm Share distributed 27,000 pounds of food.

TESTIMONY:

Young men like A.J. makes our work worthwhile. As a 23 year old ex-offender his options were limited. What a testimony this young man has since coming to us. He moved to this area uncertain of a career path, but did have a desire for writing and journalism. Upon referral to Workforce Plus, A.J. took an assessment test.

Behold, A.J. was not only proficient in writing, but score high marks in math. So much so that Pastor took him under his wing to mentor him along with our FSU intern, Oceo Harris. Because of his scores, we encouraged him to look at the path of STEMS. He said he needed some time to think about it, but after reviewing his options, A.J. decided to move forward with mechanical engineering and robotics. He has been on the dean's list for three semesters. He was recruited to represent his school in Atlanta, which at the time was a violation of his probation.

Pastor prayed with him--told him to get letters of references from school officials and his transcripts. Pastor also wrote a letter. But God... When A.J. appeared in court, the judge, seeing his grades and reading the letters, decided to canceled his probation and reduce his fines to three hundred dollars. He is now free from probation, and also free to pursue his academic goals.
